You can apply for Safety Equipment such as Soaps, Sanitizers, Face Masks, Bottled water and it can also be used to pay fuel for your volunteers. It cannot be used for any other expenditure.

Whilst Food For Life Get Togethers community small grants offer is paused, our programme has made available Emergency COVID-19 small grant fund to assist with community led responses that are centred around food, growing & social isolation responses. We are seeking applications to the value of £1,000.

To enable us to get this money into our communities where it is needed quickly, the turnaround time for applications is short.

At this time we have 12 grants available in Northern Ireland (location conditions apply) Dependant on the number of applications we could potentially receive, we reserve the right to close the application round early. Please find attached the application form which provides full information and for your ease I have bullet pointed the application criteria below so that you can ascertain at a glance whether this is a grant you'd be interested to apply for below. If you wish to apply or would like to recommend an organisation who could benefit then please let me know on return, alternatively call me on 07468 691308 should you have any questions.

Funding criteria:

- Initiatives responding to localised food poverty and food insecurity, e.g. community led food aid, food supplies and distribution.
- Initiatives that remotely connect people and groups through good food cooking, growing or connections.
- Equipment costs for community led responses (e.g. digital support, packaging, refrigeration, cooking, PPE requirements)
- Transport costs, e.g. of food supplies, petrol, volunteer costs.
- Initiatives responding to reducing experience of social isolation and loneliness through good food-based activity (e.g. digital equipment and training, virtual activities, a chance to chat on a doorstep).
- Growing food, initiatives that respond to community needs to cook, grow and connect through good food, (e.g. doorstep food deliveries or community collection of seed & soil to grow, digital growing support).

Community Foundation NI's (CFNI) Coronavirus Community Fund

Community Foundation broadens criteria for Coronavirus Community Fund and DAERA Minister, Edwin Poots MLA announces £200,000 towards the 'Coronavirus Community Fund'.

Adapting to what we've been hearing from groups on the ground, other funders in NI and the changing daily challenges presented by Covid19, **the Community Foundation will now broaden the focus of the Coronavirus Community Fund.**

We want to support community groups working together; particularly in smaller geographical communities. We will therefore encourage a partnership approach, and one application from one lead organisation, rather than a number of separate applications. Groups working with people of all ages and at increased risk as a result of the virus, particularly in relation to poor mental health and wellbeing and vulnerable isolated people, particularly in rural areas will now be eligible to apply for funding. The fund will also continue to support older people and will seek applications for funding of between £1,000 and £10,000.

For organisations providing small scale emergency support, funding of between £1,000 to £2,500 will be available which organisations supporting need on a longer-term basis, and/or who are significantly enhancing their services at this time, can apply for grants of up to £10,000.

Who can apply: Constituted organisations based in Northern Ireland. We want to support community groups working together; particularly in smaller geographical communities. We will therefore encourage a partnership approach, and one application from one lead organisation, rather than a number of separate applications.

Criteria: The fund will be open to constituted community organisations throughout Northern Ireland.

The current focus is to support groups and organisations working with the following communities and issues and that are affected by coronavirus:

Older people (aged over 50)

- ✓ Those at increased risk, particularly in relation to poor mental health and wellbeing
- ✓ Vulnerable isolated people and families, particularly those living in rural areas, families where a parent/ both parents have lost their employment or where children are living in poverty
- ✓ Children and young people's projects, particularly focusing on the voice of young people and connecting through creative mediums

With grant sizes of **between £1,000 to £10,000**, it is the expectation that this funding will support organisations to continue to provide services over the next twelve months **enabling both short and longer term impact.**

The Foundation will prioritise:

- ✓ Initiatives that directly support those most at risk as a result of the threat of coronavirus, and clearly evidence the need for support
- ✓ Organisations with income levels of below £500,000 per annum
- ✓ Running costs for organisations to provide such support, including volunteer expenses, staff costs, and transport; providing the organisation is focusing their attention on providing support to both existing, and any potential new beneficiaries
- ✓ Small capital costs are eligible, providing the capital item will address the priorities of the fund, and is linked to keeping the older person connected to the outside world.

Sport NI – Sports Hardship Fund

In partnership with the Department for Communities, our [Sports Hardship Fund](#) aims to deliver immediate funding to those most in need. It's specifically targeted at sports clubs, and other organisations delivering sporting activities, who are experiencing immediate financial hardship.

We are aware that there are a number of other larger funding sources available and we would encourage you to check those sources before applying to the Sports Hardship Fund, as in many cases they may have larger grants available that may be of more value to your organisation. We recognise that demand for these grants may outstrip supply and we want to assure you that we are doing everything we can to secure additional resources and continue to support the sporting sector.

The types of organisations eligible include Governing Bodies of Sport, local sports clubs forced to close at short notice but who are facing ongoing costs around rent or lease costs, sports facility maintenance and utility bills; community and voluntary sector organisations and charities who deliver or enable sport and/or physical recreation.

Who we can support - Any organisation delivering sport and physical recreation can apply to our fund if experiencing short term financial hardship. These organisations include:

- National Governing Body of Sport (based in NI)
- Constituted local sports clubs affiliated to a Governing Body of Sport recognised by Sport NI
- Community & Voluntary sector organisations that deliver or enable sport and/or physical recreation
- Small charitable trusts that do not qualify for financial help elsewhere

What we'll fund - The fund has been developed to help sport and physical recreation organisations meet their obligations, in particular fixed costs, which are no longer supported with revenue as a result of coronavirus. This might cover expenditure on:

- Rent/Lease
- Utility costs
- Essential ground maintenance
- Insurances

How much we'll fund - Each successful applicant will receive **£2,000 for costs incurred from 1st April 2020**.

Heritage Fund – Heritage Emergency Fund

We are providing a package of support for the heritage sector as a response to the coronavirus (COVID-19) crisis. The Heritage Emergency Fund is short-term funding to support the immediate actions needed to stabilise operations and manage unforeseen risks. You can apply to us for a grant between £3,000 and £50,000 to cover unavoidable costs you will otherwise be unable to meet for up to four months. You should only apply to us for essential costs.

This includes increased advice and support, longer-term skills and capacity building initiatives, and a £50 million Heritage Emergency Fund to provide emergency funding for those most in need.

We are also currently developing longer-term support and more information on this will be available soon.

The Heritage Emergency Fund is accepting applications for funding from £3,000 to £50,000. The application form will be **available from Wednesday 15 April and you will be able to apply until 30 June 2020.**

We expect high demand for this fund and will prioritise funding against the criteria list below.

Who can apply?

As a National Lottery distributor, we are prioritising urgent funding in the heritage sector. We want to safeguard heritage sites and organisations we have previously invested in to ensure they are not lost to the public. To apply for the Heritage Emergency Fund, you must be:

- a not-for-profit organisation
- a current or previous recipient of a grant directly from us
- an owner, manager or representative of heritage, or be able to show you have delivered participatory heritage activity

You must meet all three criteria above to apply for funding through the Heritage Emergency Fund. If you do not meet these criteria, you may be eligible for other support as we develop our longer-term strategic support or other initiatives.

National Lottery Awards for All Northern Ireland (New COVID-19 restriction)

A quick way to apply for smaller amounts of funding between £300 and £10,000.

Suitable for voluntary or community organisations. In a statement, CEO Dawn Austwick stated all the funding decisions they make for the next six months (up to £300m of National Lottery funding) will be devoted to addressing the current crisis. This is restricted to: (a) Activities specifically geared to supporting communities through this crisis, and (b) Helping organisations overcome any liquidity issues caused by COVID-19.

Clothworkers Foundation: Emergency Capital Programme

The Clothworkers' Emergency Capital Programme (CECP) will award small capital grants of up to £5,000 for essential capital items to adapt or increase services in response to the novel coronavirus (Covid-19) pandemic. Priority will be given to organisations supporting vulnerable and 'at risk' groups within their [programme areas](#) during this period.

They recognise the immediate need for capital items and aim to make quick decisions on applications. However, if they receive a large volume of applications it may take up to two weeks for a decision to reach you.

They expect the criteria for this programme to evolve as their understanding of the needs of organisations supporting beneficiaries in their programme areas develops.

Applications are only open to **charities whose beneficiaries are not based in London**

They will award capital grants of up to £5,000 (but they will not award grants equal to more than 50% of your annual income)

They aim to communicate a decision within one week (but it may take up to two weeks)

Coronavirus: Chancellor announces aid for charities

Chancellor Rishi Sunak has announced a £750m package to keep struggling charities afloat during the coronavirus pandemic.

The move follows concern that some charities are facing collapse, with income shrinking because of enforced shop closures. Bigger charities such as Oxfam and Age UK have furloughed two-thirds of staff.

The measures involve cash grants direct to charities providing key services during the crisis. As part of the scheme, £360m will be directly allocated by government departments to those charities. Another £370m will go to small local charities, including those delivering food and essential medicines and providing financial advice.

Invest NI COVID Small Business Grant

A grant of £10,000 will be paid to small businesses that already pay reduced business rates because of Small Business Rate Relief (SBRR). SBRR is automatically applied to business properties with a rateable value below £15,000, though some exclusions apply:

- Search the [Valuation List](#) to find the rateable value of a business property, also known as the Net Annual Value (NAV)

Coronavirus Business Interruption Loan

The temporary Coronavirus Business Interruption Loan Scheme supports SMEs with access to loans, overdrafts, invoice finance and asset finance of up to £5 million and for up to 6 years.

The government will also make a Business Interruption Payment to cover the first 12 months of interest payments and any lender-levied fees, so smaller businesses will benefit from no upfront costs and lower initial repayments.

Application deadline: none specified.

Facebook Small Business Grants Program

Facebook is offering \$100m in cash grants and advertising credits for up to 30,000 small businesses that are facing disruptions due to the virus.

Application deadline: none specified.

Self-employment Income Support Scheme

The Self-employment Income Support Scheme (SEISS) will support self-employed individuals (including members of partnerships) whose income has been negatively impacted by COVID-19. The scheme will provide a grant to self-employed individuals or partnerships, worth 80% of their profits up to a cap of £2,500 per month.

Application deadline: none specified.

Coronavirus Job Retention Scheme

Under the Coronavirus Job Retention Scheme, all UK employers with a **PAYE** scheme will be able to access support to continue paying part of their employees' salary for those that would otherwise have been laid off during this crisis.

This applies to employees who have been asked to stop working, but who are being kept on the pay roll, otherwise described as 'furloughed workers'. HMRC will reimburse 80% of their wages, up to £2,500 per month. This is to safeguard workers from being made redundant.

Application deadline: none specified (expected to open end of April 2020).
